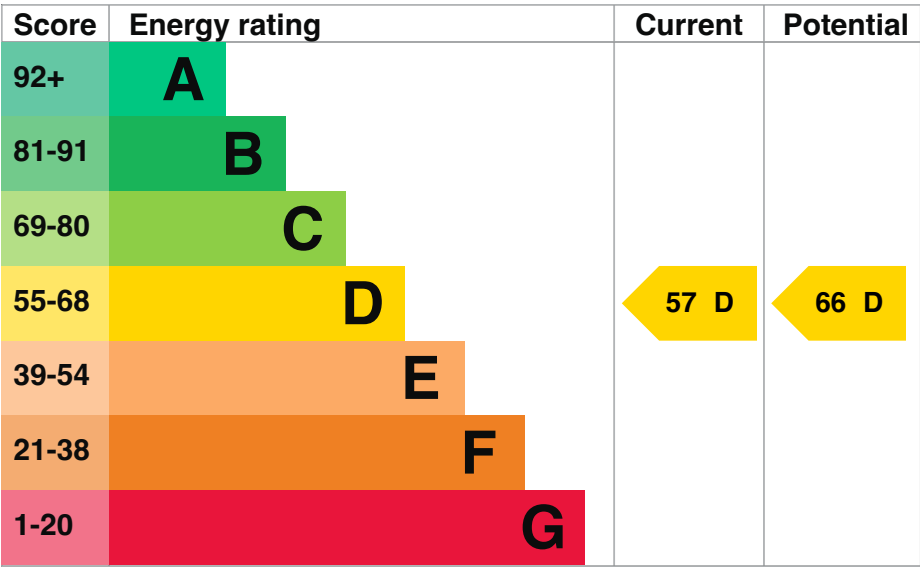

Primary energy use

How this affects your energy bills
